MY COMMITMENT TO VOTERS AND OTHER CITIZENS

I will never vote to violate the Constitution or to deprive any innocent person of his God-given rights or liberties. I will never vote for new or increased taxes, fees or regulations for anyone. I will perform my duty as a Congressman to propose **the impeachment of Barack Hussein Obama** for treason, war crimes, murder, destroying the Constitution and trying to impose a dictatorship on us. controls your health you are a slave. Meddling in issues such as whether people can drink raw milk or deciding what vitamins and medical therapy they can use is not the business of government. I want to **close down the Department of Education** and **defund and repeal Common Core**, No Child Left Behind and all other fedgov interference in education. The fedgov has no constitutional authority in this area and its "federal aid" and control have greatly increased prices and lowered standards. Education should be privatized or at least controlled at the local level by parents and other taxpayers.

END THE DRUG WAR

The Drug War is a war on liberty. Like the other unconstitutional overseas wars, it should be ended immediately and all federal prisoners should be pardoned. I favor repeal of all federal drug laws, especially the 1906 Pure Food and Drug Act which regulates labeling of cocaine and heroin, the 1914 Harrison Narcotics Tax Act, which was proposed by Francis Harrison, a member of Skull and Bones Class of 1895, which regulates opiates and cocaine, the 1937 Marijuana Tax Act, which taxed marijuana and caused the United States to have a higher prison population than Red China, the 1961 Convention on Narcotics Treaty to control marijuana and the 1970 Controlled Substance Act which established scheduling lists for drugs. The Constitution of the United States does not authorize any of these laws and they are unenforceable without creating a police state.

EQUAL RIGHTS FOR EVERYONE, EVEN WHITE PEOPLE

I favor **repeal of the Civil Rights Act of 1964** which abolished the right of private property in land for all Americans in accordance with the teachings of Karl Marx. In a free country, people have the right to sell or rent their property to, and hire and fire, whomever they wish. Affirmative action is racism of the worst form. There is nothing reverse about it. While compulsory state segregation was wrong, compulsory federal integration is worse since it is much more difficult to leave the US than to move to another state.

All federal judges should be required to notify jurors of their right to acquit if they believe that the defendant was charged under an unjust law or if they believe that the defendant was treated unfairly by police or prosecutors. **Jury Nullification** is the basis of freedom of the press, the abolitionist movement and resistance to alcohol Prohibition. See The Fully Informed Jury Association www.fija.org. All federal employees, especially members of the armed forces, should be required to take the **Oathkeepers Oath** to constantly remind them that they are servants of the people and that it is never lawful to attack, disarm or enslave the American people or deprive us of any of our God-given, constitutionally guaranteed liberties, especially freedom of religion, speech, the press, the right of assembly and to petition the government and the individual right to keep and bear arms. **Marriage** is not a constitutional federal concern. The states should uphold all voluntary marriage contracts which do not impose obligations on third parties. I want to make English our official language. I will support all state nullification efforts to preserve liberty and the Constitution. I favor repeal of all federal prostitution, pornography and gambling laws. I want to repeal the National Minimum Drinking Age Act of 1984, funding for Child Services kidnappers and the Violence Against Women Acts of 1994 and 2005. I support Downsize DC's Read The Bills Act: tinyurl.com/mm7yzgk

I favor revision of the patent, copyright and trademark laws to prevent restriction of use by buying up patents and copyrights and preventing use of products and information and to keep the government from censoring citizens by

trademark control. I will vote to abolish the Selective Service System. A nation which cannot be defended voluntarily does not deserve to exist.

SOCIAL SECURITY must be phased out with everyone given as much opportunity as possible to retrieve what was taken from him and to get out of the system. Disclaimer: I am stealing back Social Security taxes which were taken from me.

ELECTION REFORM

I support instant runoff voting, which allows voters to rank their choices and ends the fear of "vote splitting". Paper ballots should be counted manually at each precinct and "None of the Above" should always be a choice. The Voting Rights Act of 1965, multilingual ballots and all federal laws which require micromanagement of elections should be repealed. Special privileges to political parties, including repressive ballot access laws, should be repealed.

PROPOSED CONSTITUTIONAL AMENDMENTS

I **oppose a Constitutional Convention** for the foreseeable future. Based on the precedent of the 1787 Constitutional Convention, there is no way to control it. The delegates to the convention would be chosen by the same electorate which has inflicted Bushes, Clinton and Obama on us for almost 30 years. It would be worse than giving a five year old a box of matches and sending him to play in a nitroglycerine factory.

I favor the **Liberty Amendment**. (See END THE DEPRESSION above.) I support a Balanced Budget amendment so long as there are provisions that the budget will never be balanced by higher taxes or by inflation and there are no loopholes. I will submit the **14th Amendment** for proper ratification and recommend that it not be ratified because the fedgov and other enemies of liberty have used and misused it to rob us of our liberty. I support the Bricker Amendment which was proposed by former Senator John Bricker of Ohio to end longstanding confusion and determine that treaties cannot supersede the Constitution, especially the Bill of Rights. I support **repeal of the Seventeenth Amendment** to end the direct election of Senators and restore a constitutional federal/state balance.

I also support these proposed Constitutional amendments:

"Congress shall make no law that applies to citizens of the United States that does not apply equally to the Senators and/or Representatives; and Congress shall make no law that applies to the Senators and/or Representatives that does not apply equally to citizens of the United States." **"Neither Congress nor the States shall limit, hinder or restrain commerce."** (Suggested by Sheldon Richman, editor of The Freeman)

It might be worthwhile to establish a third house of Congress, a People's Veto, with one representative for every 30,000 persons with the ability to veto any legislation. Other proposals to consider are reducing the terms of the president to two years, Senators to three years and Representatives to one year, Supreme Court justices to nine years and increasing the size of the House of Representatives to 700 with 200 being chosen by parties through proportional representation as long as parties have special legal status. If a majority of the district requests, I will support term limits for Congressmen.

He sold insurance and was an adjuster at several financial institutions including Key Bank for 28 years until he retired in 2001. He has been a member of the Libertarian Party since 1980 and a Life Member since 1988. He is currently a member of the State Central Committee of the Libertarian Party of Ohio. He has run for office five times: State Representative Dist. 16 American Party 1972, 1395 votes 3.33% 3 way race, US House of Representatives Dist. 14, Libertarian Party and all subsequent campaigns 2008, 9511 votes 2.94% 3 way race, State Representative Dist. 17 2010, 2812 votes 5.56% , a tie for the second highest percentage of votes for any alternate party candidate in a 3 way state legislative race in Ohio in 2010, US House of Representatives 2012, 11,536 votes 3.39% 4 way race and again this year for US Congress in the 14th Ohio District. **He is the only peace candidate for Congress in northeast Ohio as the international banksters threaten to start World War III.** He has attended all Libertarian National Conventions since 1987 except 2012 and most state conventions since the early 1980s, as well as the American Party conventions of 1972 and 1976. THE POWER OF THE HOUSE OF REPRESENTATIVES

The federal House of Representatives initiates all spending measures (Art. 1, Sec. 7, Cl. 1 U.S. Constitution). 218 members of Congress who had sufficient courage and refused to compromise their oaths of office, even if most of the Senate and the President were traitors, could stop all unconstitutional, treasonous, idiotic policies which created our police state, World War III and economic collapse, all of which require money to finance the destruction of our country. If the government becomes totally out of control, 218 could shut it down.

IMPEACH BARACK OBAMA

The House of Representatives has failed to do its duty to impeach

Barack Hussein Obama for treason, murder, war crimes, destroying the Constitution and establishing a dictatorship. The Senate has failed to do its duty to convict Obama and remove him from office. Every succeeding President has expanded on the violations of his predecessors to bring us to the point of total destruction of the Constitution and dictatorship. Until there are consequences for these violations (e.g. the impeachment of the President) this process will continue until we are totally destroyed. This is not a partisan attack. Both Rebloodlicans and Democrips have been accessories. **To its great credit and honor, Veterans for Peace** veteransforpeace.org, hardly a "right-wing extremist" group, called for the impeachment of Barack Obama at its 2011 National Convention. Among their charges was his unconstitutional war on Libya, his continuation of Bush Jr.'s unconstitutional wars in Iraq, Afghanistan, Pakistan, Yemen and Somalia, his use of weapons which cause great harm to civilians (in violation of the Geneva Conventions and other international laws) and the deaths and maiming of millions of civilians, by failing to prosecute Bush, Cheney and their henchmen for their war crimes: tinyurl.com/kj37a2d **Two excellent books, Impeachable Offenses: The Case For Removing Barack Obama From Office** by Aaron Klein & Brenda J. Due to space limitations, the following is a very brief, incomplete list of some of Obama's offenses. Undoubtedly, by the time you read this flyer, there will be more. **Like all communist and other socialist would-be dictators**, Obama seeks to destroy our God-given rights, guaranteed by the Second Amendment of the Constitution, to keep and bear arms to defend ourselves from tyrants and private criminals. A glaring example is the murderous Fast and Furious gun-running scandal which was meant to discredit American gun owners, for which Attorney General Eric Holder should be impeached. Obama has issued dozens of unconstitutional executive orders to restrict our rights, especially after conveniently timed killings, most of which occurred in "gun-free" disarmament zones. Over 175,000 veterans have been disarmed without due process. **Obama** shoved the unconstitutional, communistic **Obamacare** through a Democrip controlled Congress, unconstitutionally issued executive orders to change many of its provisions for political purposes, somehow blackmailed Chief Justice John Roberts to declare it constitutional and lied 36 times in one speech that nobody would lose his doctor, his insurance coverage or pay higher premiums. In a grim preview of what will happen to all Americans if Obamacare is not defunded and

repealed, Obama allowed his Veterans Administration to permit the deaths of dozens of veterans and to try to cover up the atrocities as he has done with almost all of his crimes, including the deaths of Anwar al-Awlaki, a natural born American, his son and nephew. **Obama** has allowed massive, unprecedented spying on the American people, amounting to a declaration of war on us (treason) by the National Security Agency and other agencies which apparently deny the existence of the Fourth Amendment guarantee against unconstitutional search and seizure. He has persecuted whistleblowers for the crime of telling the truth in an age of deceit, foremost among them the great hero, **Edward Snowden**, whom he drove into exile, at least until a Libertarian president pardons him. **Obama** misused the Infernal Revenue Service to harass and persecute patriots and his henchmen and henchwomen, including Lois Lerner, tried to suppress evidence of these crimes. He is also persecuting other patriots such as Dinesh D'Souza. He and former Secretary of State, Hillary Clinton, are attempting to conceal the crimes related to the death of US ambassador, Christopher Stephens in Benghazi, Libya, which he had unlawfully invaded and destroyed and which was being used as a base to smuggle weapons to alCIAda in Syria, another country in which he had unconstitutionally meddled. Spreading propaganda to promote **the hoax of manmade climate change and global warming**, which has not occurred for over 15 years, Obama used the unconstitutional Environmental Protection Agency to shut down the coal industry and, together with numerous other regulations, destroy what remains of our economy, generally considered an act of war. **Obama**, in collusion with the corrupt government of Mexico and other banana republics, is facilitating an invasion of the United States in direct violation of his duty to protect the sovereign states from foreign invasion. The questions of his citizenship are still unresolved. Is his father the Kenyan communist, Barack Hussein Obama Sr. or the American communist, Frank Marshall Davis? Is he a natural born citizen? Did his communist CIA agent mother, Stanley Ann Dunham Obama Soetoro, surrender his citizenship while they lived in Indonesia?

MACKO PROPOSES TO END THE POLICE STATE

The National Defense Authorization Act of 2012, subsequently extended twice, purports to authorize Obama to kidnap and imprison any American indefinitely without trial. He also allegedly has the power to kill anyone with drone strikes. This law, the abominable USA PATRIOT Act, the Real ID Act, the John Warner "Defense " Act, the thuggish Transportation Security Agency, the Federal Bureau of Investigation, the Central Intelligence Agency, the National Security Agency (which is spying on over 300 million Americans) and all other spy agencies must be abolished, to be replaced by one agency, functioning according to the Constitution, under limitations of the Fourth Amendment. I also favor abolition of all federal "aid" which encourages nationalization of local police and police-state style behavior. I favor prosecution of James Clapper, Director of National Intelligence, who lied to Congress that the government was not spying on the American people, effectively an act of war, and all others who lie about government wrongdoing. The Posse Comitatus Act of 1878 which prevents the use of the armed forces to enforce domestic law must be restored. To end the police state, we must expose the truth about 9-11, which was an inside job conducted by the Bush regime with the Mossad and the government of Saudi Arabia, for the purposes of starting World War III, establishing a police state and merging

the United States into a one-world totalitarian government under the United Nations. The manner in which the Twin Towers and Building 7 collapsed contrary to the laws of physics, the repudiation of the official story by hundreds of scientists, the ability of four hijacked planes to fly unmolested for so long, the orders by Dick Cheney not to shoot down the planes and advice to government officials not to fly on 9-11 are all damning evidence of conspiracy. THE IMMIGRATION INVASION

We do not have an immigration problem. We have an invasion problem. Beginning in summer 2014 this problem has accelerated to such a level as to be reminiscent of the great novel by Jean Raspail, *The Camp of the Saints*, available at: tinyurl.com/pz799kz I disagree with the official position of the Libertarian Party regarding this issue. However, for a rational libertarian position see A Libertarian Argument Against Open Borders by John Hospers, the first Libertarian candidate for president at http://mises.org/journals/jls/13_2/13_2_3.pdf We do not need a pathway to citizenship. **We need a pathway back to Mexico.** In collusion with Mexico and the banana republics of Central America, Obama has turned the Border Patrol into a babysitting and smuggling service for the young illegal aliens and the invasion has become impossible to ignore. If we do not repel and reverse this invasion, we will cease to exist as a nation. I support the renewal of President Eisenhower's successful program of 1954, Operation Wetback, which returned 2,000,000 illegal aliens to their homes without violation of the Constitution. I believe that the fedgov program of unlimited immigration was designed to destroy America as a predominantly White Christian nation and to make it impossible to restore the concept of limited Constitutional government. While we repel the invasion, we must protect the Constitution. Therefore, I oppose a national or "real" ID or compelling American businessmen to become unpaid government agents by reporting all new workers to any unconstitutional government employment data base. Until Operation Wetback II is complete, I support a moratorium on immigration. Then, it should be restricted to no more than 1/10th of one percent of the American population per year so that immigrants can be assimilated to American principles of liberty. I favor restoration of the Immigration and Nationality Act of 1952 to restore balance.

MACKO WANTS TO STOP WORLD WAR III

Since 9-11 the enemies of the human race have been moving relentlessly toward World War III, just as they caused World Wars I and II. The destruction of Iraq, Libya and Syria by "our" government and the Arab Spring turmoil have created chaos throughout the Middle East. MACKO WANTS TO END THE DEPRESSION

I support the Liberty Amendment www.libertyamendment.org, a proposed Constitutional amendment which has been supported by Hon. Dr. Ron Paul and other statesmen and which would require the fedgov to sell all unconstitutionally held land (over one million square miles) and other properties so that the Marxist federal income, gift and death taxes and some other taxes could be repealed in three years. Pending repeal, I favor a moratorium on income and payroll taxes until the depression ends, repeal of the gasoline tax and return of federal highways to the states or privatization as they determine. The **abolition** of the unconstitutional Environmental Protection Agency, the Occupational Safety and Health Administration, the Departments of Commerce, Transportation and Labor, federal minimum wage laws and most other government edicts would help restore the flow of commerce (the original intent of the term "regulation"). Pending removal or drastic reduction of limited liability from private and government corporations, **corporate taxes** should be reduced to the level of the rest of the world. **Executive orders** and bureaucratic edicts which affect any American who is not a government employee are unconstitutional and should be nullified by Congress. All new ones should be approved by Congress in the same manner as laws. I favor the abolition of the Department of Energy and all taxes, edicts, court orders, regulations and subsidies which hinder, restrict or otherwise impede the discovery, production, distribution and sale of all forms of energy: gas, oil, nuclear, coal, hydroelectric, wind, solar or any new form of which we are unaware. Examples of government hindrance include Keystone Pipeline and the decades-long suppression of energy development at Gull Island, Alaska. END THE FED

Most importantly, to ensure future prosperity, we must audit and end the Federal Reserve System, one of the ten planks of the Communist Manifesto. An honest audit will educate and arouse the American people as to how the international bankster enemies of mankind have raped

MACKO WANTS TO RESTORE THE RIGHT TO KEEP AND BEAR ARMS

I will work to defund and abolish the unconstitutional Bureau of Alcohol, Tobacco, Firearms and Explosives and repeal all federal firearms laws, especially National Firearms Act (1934), Federal Firearms Act of 1938, Omnibus Crime Control and Safe Streets Act of 1968, Gun Control Act of 1968, Undetectable Firearms Act (1988), Gun-Free School Zones Act (1990) (ruled unconstitutional as originally written; has been upheld repeatedly after minor edits were made by Congress) and the Brady Handgun Violence Prevention Act (1993). I will work to repeal all taxes on firearms and ammunition, any new gun laws, especially re-imposition of the Federal Assault Weapons Ban and any attempts by the UN to disarm American citizens and lawful guests. I favor restoring the right to keep and bear arms of the 175,000 veterans who were deprived of their rights without any proper judicial procedure. Throughout the 20th century gun confiscation was a precursor to dictatorship and massacres.

MACKO BELIEVES THAT THE RIGHT TO LIFE SHOULD BE PROTECTED FROM CONCEPTION TO NATURAL DEATH

Abortion is murder, but the Constitution regards it as a state (not a federal) crime. When you give the government the power to decide who is a human being, as when the Soviet Russian government dehumanized Czarists, the Russian nobility, Orthodox priests and nuns, businessmen and kulaks (who were prosperous peasants) and when the National Socialist German government dehumanized Jews, Slavs, Gypsies, and homosexuals, the result is always a totalitarian government which often murders millions of innocent people. I will promote legislation to remove the appellate jurisdiction of the Supreme Court from abortion cases, thus nullifying Roe vs. Wade and other anti-life decisions which have caused the deaths of almost 60 million preborn Americans. I support the Hon. Dr. Ron Paul's Sanctity of Life Act which would end all fedgov support for abortion. I disagree with the Libertarian Party platform plank on the right to life. HEALTH AND EDUCATION FREEDOM: REPEAL OBAMACARE

I will work to **defund and repeal Obamacare** and all other socialized medicine laws including Medicaid, Medicare and Bush's Medicare drug program. I will strive to abolish the Department of Health and Human Services and the Food and Drug Administration.
